- 3. A proxy may but need not be a member and there shall be no restriction as to the qualification of the proxy.
- 4. Where a member is an Authorised Nominee as defined under The Securities Industry (Central Depositories) Act, 1991, it may appoint at least one proxy in respect of each Securities Account it holds with ordinary shares of the Company standing to the credit of the said Securities Account. Ordinary Business

1. Item 1 of the Agenda - Audited Financial Statements for the year ended 31 July 2024

This Agenda item is meant for discussion only and does not require a formal approval of the shareholders and hence, is not put forward for voting.

Special Business:-

2. Ordinary Resolution 7 – Authority to Issue Shares pursuant to Sections 75 and 76 of the Companies Act 2016

The Company had, during its 8th Annual General Meeting held on 21 December 2023, obtained its shareholders' approval for the general mandate for issuance of shares pursuant to Section 75 and 76 of the Companies Act 2016.

The Company has not issued any new share pursuant to the mandate which was granted at the last Annual General Meeting held on 21 December 2023.

On 12 November 2024, the Board of Directors had announced that the Company proposes to undertake a private placement of up to 10% of the total number of issued shares (excluding treasury shares, if any) ("Proposed Private Placement") which will be undertaken in accordance with the general mandate pursuant to Section 75 and 76 of the Companies Act 2016 obtained at the Company's 8th Annual General Meeting convened on 21 December 2023.

A total of up to 18,533,610 new Shares ("Placement Shares") representing 10% of the total number of issued shares of the Company may be issued pursuant to the Proposed Private Placement.

Barring any unforeseen circumstances and subject to receipt of all required approvals, the Board expects the Proposed Private Placement to be completed by the 4th quarter of 2024.

The Proposed Ordinary Resolution 7 is to seek a renewal of the general mandate from the shareholders of the Company at the 9th Annual General Meeting held on 18 December 2024.

The general mandate, if passed, will provide flexibility for the Company and empower the Directors to allot and issue new shares in the Company for any fund raising activities, including but not limited to the placing of shares, for working capital, funding future investments and/or funding of strategic development of the Group. The new general mandate is sought to avoid any delay arising from and cost in convening a general meeting to obtain approval of the shareholders for such issuance of shares, up to an amount not exceeding in total ten percent (10 percent) of the issued and paid-up share capital of the Company, as the Directors consider appropriate in the best interest of the Company. The authority, unless revoked or varied by the Company at a general meeting, will expire at the next Annual General Meeting of the Company.

Pursuant to Section 85 of the Companies Act 2016 read together with Clause 64 of the Constitution of the Company, shareholders have pre-emptive rights to be offered any new shares in the Company which rank equally to the existing issued shares in the Company or other convertible securities.

In order for the Board to issue any new shares such pre-emptive rights must be waived. The proposed Ordinary Resolution 7, if passed, will exclude your statutory pre-emptive rights over all new shares to be offered and issued pursuant to the Mandate.

The Board, having considered the current and prospective financial position, needs and capacity of the Group, is of the opinion that the general mandate is in the best interests of the Company and its shareholders.

Voting by Poll

Pursuant to Paragraph 8.29A of Bursa Malaysia Securities Berhad's Main Market Listing Requirements, all resolutions set out in this notice is to be voted by poll.
